

MedTech Innovator is a 501(c)(3) non-profit organization dedicated to improving the lives of patients by accelerating the growth of companies transforming the health care system. Each year, outstanding early and mid-stage medical device, diagnostic and digital health companies are selected to participate in the program and compete for nondilutive cash prizes. Since 2013, MedTech Innovator has awarded \$2.6 million to past participants. Alumni have gone on to raise over \$2.8 billion in equity funding. This year's competition began in November 2020 with over 1,100 applications submitted. From February through May, the highest-scoring applicants from online reviews were invited to 14 pitch events on MedTech Innovator's virtual road tour. Over 300

industry representatives, including investors, business development executives and subject matter experts, joined the MedTech Innovator team to meet with and evaluate the companies. From there, 55 outstanding companies were selected to participate in the MedTech Innovator Showcase at The MedTech Conference. Each company receives one Full Access registration as well as access to exclusive programming and networking opportunities. Twenty-five of the MedTech Innovator Showcase companies participate in a four-month virtual accelerator, which provides companies with the opportunity to receive customized, indepth mentorship from industry stakeholders. Five finalists go on to compete for the title of MedTech Innovator 2021.
